All ticket stubs will be placed into a rotating drum and drawn individually in prize order from lowest value to highest value (excluding Early Bird prize). After each stub is drawn and photocopied, it will be placed back into the drum for the next draw.
- Board members or members of their households — of the Edmonton Humane Society are not eligible to purchase tickets.
- **4.** Employees or members of their households categorized as "Management" within the Human Resource policies of the Edmonton Humane Society are not eligible to purchase tickets.
- Employees or members of their households in the Fund Development or Accounting departments of the Edmonton Humane Society are not eligible to purchase tickets.
