| FRONT | •Front Princess Seam | Increase shaping at front princess seam at bust. Reduce shaping at side seam. See image below. |
| | •Side Hood | Fill in at side hood. See image below. |
| | •Front Flap | Add 80 needlepunch to front flap as it is too lightweight on sms. See updated BOM. |
| | •Forearm Circumference | Forearm circumference measurement deleted. |
| | •Waist Circumference | Point of measure revised to show placement from HPS. Placement raised from previous sample. See image below. See measurement tab. |
| | •Hip Circumference | Point of measure revised to show placement from HPS. Measurement increased. See revised spec. Add increase to back princess seam at hip to increase shaping in this area. See image below. |
| BACK | •Back Kick Pleat | Delete back kick pleat. |
| | •Back Princess Seam | Add shaping to back princess seam at hip. See image below. |
| INTERIOR: | | |
| | •Binding at waist | Delete binding at waist. It creates too much bulk. See Lining tab. |
| | •Chest pocket tab | Chest pocket tab dimensions should be 1 3/4"l x 1"w. |
| TRIMS: | | |
| | •CF Snaps | Top snap placement keep as sample (3/8" from top collar edge). Bottom snap placement should be 2 1/2" from bottom of zipper. See cover page. Space remaining snaps evenly in between. |
| | •CF Zipper Pull | CF zipper pull should be large rubber zipper pull. Article number corrected to #P125. |
| | •Marmot Logo Embroidery | Logo embroidery should be applied evenly. See image below. |
