* APR= Annual Percentage Rate. Rates are based upon the appraised home value and the combined loan-to-value (CLTV) of the first and second mortgage, credit and income. If the CLTV is greater than 85%, other restrictions may apply. Available on owner-occupied residential property in all states and the District of Columbia, except Alaska, Hawaii, and Texas. The home equity loan has a fixed rate that is a fully amortized loan for the life of the loan (no balloon payment). The Home Equity Line of Credit (HELOC) has a variable interest rate that is based on the Wall Street Journal Prime Rate and is subject to change quarterly. The monthly payment on a HELOC is the greater of \$100 or 1.50% of the outstanding balance as of the end of the previous month. The rate cannot increase or decrease by more than 2.00% in a calendar year, and the maximum rate is 18.00%. If the credit union pays the closing costs and the HELOC is terminated within three years, the closing costs must be reimbursed by the borrower. All rates and terms are subject to change without notice and other restrictions may apply. To qualify for the \$50 Home Depot gift card, the home equity loan or the HELOC must have a minimum balance of \$10,000 at the time of disbursement. 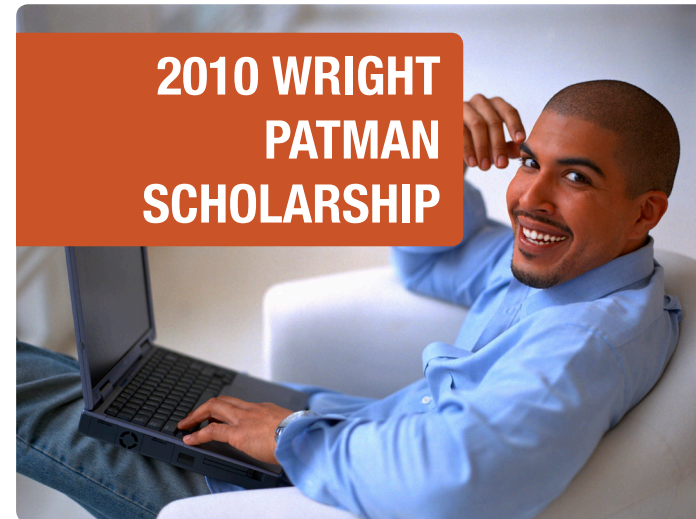
CAPITOL HILL COMPETITION - PACKET PICK UP

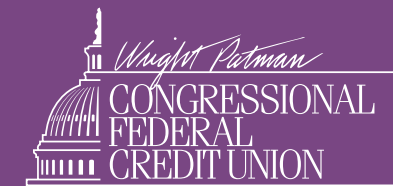
