 - Earliest any of the PCR's functionality can be delivered in a build is the 09/08/2010 build (Wednesday 9a turnover)
 - 2548: formally approve inclusion into 310
 - Bank approved to be included during various 9a calls
 - Commit estimate increased by 190 hours
 - Mid-Size Cash Deposit Bin: formally approve inclusion into 310
 - Previously approved to be included, during conversation on 8/13
 - Commit estimate increased by 18 hours
 - Cash Bin Full DLL Inclusion (From Call Reduction Program): formally approve inclusion into 310
 - Previously approved to be included, during conversation on 8/13
 - Commit estimate increased by 21 hours

 - As of 8/23/2010, Wincor has not been able to complete p2p testing






- o 33 hours spent so far
