The Designer Rewards Program and the Agreement are subject to change from time to time at the Company's sole discretion.

Once eligibility is met, and subject to the terms of this Agreement, Designers participating in the Designer Rewards Program will receive a membership discount on full-price merchandise purchased at Crate and Barrel, CB2 and The Land of Nod in the United States, excluding all Outlet locations. TERMS OF ELIGIBILITY

- Premier tier status is based on total company purchases for a calendar year (January 1–December 31).
 All members of the same design firm enrolled in the Designer Rewards program will receive the same tiered discount.
