Licensor hereby warrants, confirms and represents that they are the owner of all right, title and interest in and to the Article, and its copyright or trademark if it exists, and that the Licensor has the legal and full right to enter into this agreement. To the best of Licensor's knowledge, no other authorizations or permissions pertaining to the Article are required from any third party.

It is understood by both parties that this is an authorization by the Licensor for the Licensee to proceed with the inclusion of the Article in the preparation, production and exhibition of the Photoplay.
