We thank all of our partners for stepping forward to join us as we Build Houses, Build Hope, Build Philadelphia. We are so very humbled by your trust, support and investments. FROM THE EXECUTIVE DIRECTOR

What a year! We celebrated some significant milestones in 2011 and none would have been possible without all of our partners – City agencies, corporate and foundation partners, individual supporters and over 2200 volunteers!

We are delighted to share some highlights with you:

- In 2011, Habitat Philadelphia had 10 homes under construction. Six new, energy-efficient homes were completed, replacing one empty lots and vacant shells. Sold to first-time homebuyers, who now through their zero-interest mortgage have more choices when it comes to education, health care and child care. Sold to homeowners who are more invested in their property, their block and are now paying City property taxes. In the process, Habitat Philadelphia and our tireless AmeriCorps members engaged over 2,200 volunteers who worked tirelessly to see the houses turned into homes! Your belief and commitment to our mission humbles and inspires all of us at Habitat Philadelphia.
- •We opened our ReStore! What started as a monthly garage sale at our office in North Philadelphia, our ReStore moved, in September, into its new 19,000 SF home at the former Lomax Carpet warehouse at 2930 Jasper Street in Kensington. The ReStore is made possible with generous donations of furniture and household items and managed by volunteers. This additional and critical source of revenue will allow Habitat Philadelphia to construct more affordable quality homes for our community.
- Our homeownership program accepted 12 new partner families who have worked side-by-side with our construction staff, ReStore team and countless volunteers as they completed their 350 hours of sweat-equity. Learning in the classroom, as well as on the construction site, our partner families are some of the most educated and skilled homeowners in town!
- Excitingly, we've started developing our Weatherization and Home Repair Program model (WHRP) and will roll it out in 2012. This cost-effective program will allow Habitat Philadelphia to innovatively serve more families through basic home repair and weatherization investments and, therefore, preserve the aging housing stock and prevent families from experiencing homelessness.
- Our Building Hope Luncheon has seen fantastic growth in participation and support. This year, an audience of 640+ gathered to support the partner families of Habitat and helped raise over \$168,000 for Habitat Philadelphia. We thank all of our event sponsors and we look forward to our third annual luncheon in May 2012.

As we continue to expand and deepen our partnerships, we are especially grateful to the leadership of our Board of Directors, generosity of our donors, courage of our partner families, dedication of our staff and enthusiasm of our volunteers.

In the year ahead, we look forward to working side-by-side with you as we continue to Build Houses, Build Hope, and Build Philadelphia.

OUR FAMILIES:



Habitat Philadelphia is an investment, creating equity for our families and value for our City. Habitat homes are sold at cost – no profit, no interest – to hard-working, low-income families who contribute 350 hours of "sweat equity" toward Habitat projects. Mortgage principal payments are paid forward, through our Fund for Humanity, to help build or renovate more houses. Through its no-interest, no-profit loans, Habitat Philadelphia ensures that our families pay no more than 30% of their income for housing which empowers families to focus on other critical needs such as health care, child care, or education. To date, Habitat Philadelphia has built over 158 homes, strengthening these families and transforming nearly 550 lives forever.

OUR NEW HOMEOWNER: ANNA JOHNSON

Anna Johnson, Ricardo Henry, and their daughter, Tatiana, moved into their new home at 2240 Latona Street at the end of 2011, just in time for Christmas!

Their new home, with asthma-healthy features and wheelchair accessibility, was designed to meet 18-year old Tatiana's needs, who along with asthma, has physical limitations and a cognitive impairment. This home is one of four houses to participate in the nationwide Build Smart, Breathe Easier asthma educational program, which is joint collaboration between Merck, HGTV's Carter Oosterhouse, and the Asthma and Allergy Foundation of America.

The family had been living in a rowhome with roof and water damage, moldy carpets, poor electrical wiring and cracked walls. Anna had to carry Tatiana up and down the stairs multiple times a day to use the bedroom and bathroom. In their new residence, Tatiana's room and a bathroom are now conveniently located on the ground floor. Now that the new house has been completed, the family is also working on getting Tatiana a motorized wheelchair that will allow her to zoom ground the house!

Richele Jackson never dreamed that she would become a homeowner. Her entire family grew up in housing projects, and she never had any reason to think her life would be any different. Still, she believed in a life outside the projects and wanted more for her children and herself. She works full-time as a cook manager for the school district of Philadelphia and juggles the stress of being a single parent to Iviana (10) and Jasha (3). After meeting a Habitat Philadelphia homeowner through her job who encouraged her to apply, Richele was accepted and earned her zero-interest mortgage through 350 hours of sweat equity.

Richele is the first person in her family to ever own a home when she moved in on December 5, 2010. What really surprises her is how much more affordable her zero interest mortgage is than her rent. Before Habitat, Richele was paying almost \$600 a month to live in a housing project that was poorly maintained. Her new mortgage with taxes and insurance is about \$350 a month! The decrease in her housing costs has allowed Richele to start saving for her children's education – something she would have never been able to do before.

More than walls and a roof overhead, this home means so much more to Richele. She recently got a promotion at work, and is enrolled in college, where she is earning all A's in her classes. "Because of Habitat, I am a better mother. I have bigger hopes and dreams for myself and my children - I'm back in school, I'm a stronger person. I now think, what MORE can I do with my life?" - Richele Jackson, proud homeowner

OUR HOUSING PROJECTS:

We build Green! Habitat Philadelphia is committed to building energy-efficient homes using sustainable designs. As a matter of fact, seven of our recent homes have been LEED-certified.

In a city as rich with history and culture as Philadelphia, rehabs of row homes preserve a part of this City's unique past. Utilizing current housing stock, as well as the existing timber and bricks, rehab construction keeps these items out of landfills. Habitat works with the existing layout and provides an "extreme" makeover through improved insulation, energy-efficient windows and appliances, paint with low toxins and bamboo floors.

As our construction supervisor Cassie O'Connell says, "the greenest building is preserving one that's already built."

OPENING OF RESTORE

Reduce, Reuse, Recycle, ReStore!

What started as monthly garage sales out of our North Philadelphia Office evolved into our new 19,000 SF warehouse in Kensington open to the public four from Wednesday to Saturday every week. The ReStore represents a diverse and critical revenue stream for Habitat for Humanity Philadelphia. Donated home goods and building supplies are sold to the public at a reduced cost. These proceeds are plowed back into Habitat Philadelphia to help serve more families in need.

With the generous donation of a truck, the ReStore is equipped to accept donations of furniture, appliances, and home goods. We're also especially grateful to Temple University's Fox School of Business and the William Penn Foundation for their critical support to get the ReStore launched.

Under the leadership of Frank Siefert, board member, and the dedication of the ReStore Team and volunteers, we spent the summer stabilizing the former Lomax Carpet Warehouse and converting the space into our ReStore. Mayor Michael A. Nutter joined us for the Grand Opening on September 11, 2011 and the ReStore has been on a roll ever since. Open four days per week, the ReStore is on target to salvage over 120 tons from the waste stream in its first full year of operation!

ReStore is a win-win for everyone involved. The revenue generated represents vital and unrestricted funding for our administrative operations and program costs. The ReStore retains Habitat's 501(c)(3) status and all donations are tax deductible. And quality items are prevented from ending up in landfills. DID YOU KNOW?

1 out of 8 Philadelphia homeowners' cannot afford to make needed repairs on their home. If the roof of a house goes unrepaired, the home will be abandoned, on average, in five years.

The work continues for our construction team as they work on:

- Two houses on Latona Street (which will be dedicated by February 2012);
- Two houses in South Marston Street;
- Four new construction projects in North Philadelphia;
- One rehabilitation in North Philadelphia;
- One rehabilitation in Germantown (Priscilla Street)

What a list! Come build with us!

We will complete construction on 10 more energy-efficient homes in 2012 with the majority of the properties located in our North Central Philadelphia neighborhood. This construction will result in 10 more partner families achieving affordable homeownership and contributing to school and property taxes. Working alongside partner families, Habitat Philadelphia will engage 2200+ volunteers in the work of building safe, decent and affordable homes.

In early 2012, we will launch our Weatherization and Home Repair Program (WHRP). This program is the result of a dramatically growing need for basic home repairs and weatherization services provided for low-income homeowners. Philadelphia faces the challenge of an aging housing stock, as well as aging low-income population. It is the intention of the WHRP to preserve the existing affordable housing stock and prevent families from experiencing homelessness. WHRP will mirror the Habitat model of sweat-equity and zero-interest loans.

Habitat Philadelphia will welcome a new cohort of 12 families who will begin on their sweat-equity in May of 2012. On average, it takes partner families 18 to 24 months to complete their hours. We look forward to working alongside our new partner families.
