

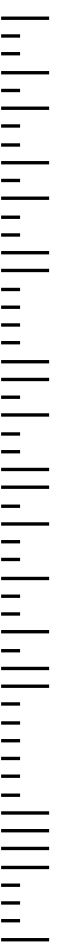

Mission Statement

STREETWORK PROJECT

When Serena first came to Safe Horizon, she was bright, beautiful ... and homeless at 15. Like up to 60% of homeless teens who walk through our doors, Serena had left a home filled with violence and abuse and ended up on the streets.

Whether violence occurs in their homes or on the streets, young people like Serena are often the victims. They turn to prostitution, crime and drugs to survive. They're vulnerable to HIV and other diseases. They're often angry, frightened, despondent, and difficult to reach, running from a violent past toward no real future. We are all entitled to a refuge, a safe place away from danger. That's why Safe Horizon founded Streetwork -- to offer a safe place where young people like Serena find the care and compassion they so urgently need.

Every year, Safe Horizon makes over 15,000 contacts with homeless and street-involved youth, distributes 35,000 meals and offers a lifeline to thousands. Our Streetwork drop-in centers and overnight shelters offer places where those who spend

so much of their lives in danger can feel safe, empowered, cared for and encouraged.

First, we meet the basic needs for food, warm clothing and medical care. Then we offer counseling, GED preparation, legal services, emergency housing, support groups and a range of other services that empower young people to begin to build a safe, secure and healthy new life.

With the help of Streetwork's critical services, Serena has made it to the safe place she was hoping for. She has found housing, earned her GED and found full-time employment. She is hoping to begin college and looks forward to starting a family of her own. What each young person receives from Streetwork is what he or she needs to take the next step on his or her own path to safety and healing, whether that is a safe place to sleep or a connection to a compassionate counselor.

With the support of friends like you, we are able to reach kids like Serena. Thank you for helping Safe Horizon move more homeless and street-involved youth from crisis to confidence.

PROGRAM: DOMESTIC VIOLENCE

Ms. Smith is a 40 year-old woman with four children who has been married for 15 years. Ms. Smith was forced to leave her home due to domestic violence. According to Ms. Smith, her husband and his family were abusive to her. Ms. Smith came to a Safe Horizon Domestic Violence Shelter in June.

Ms. Smith was a transient, staying briefly from one home to the next in her community hiding from her batterer and his parents. She decided to leave her home because her situation became life threatening. She indicated that her husband tried to kill her by attempting "to throw me out of the window". Ms. Smith was clearly in a crisis. She was scared, confused and anxious. Her stay at a Safe Horizon Domestic Violence Shelter was definitely a trying period for her. She had to acclimate herself to a completely different environment. She was distressed about where her children would attend school. There were many complicating factors in this case. Language was a major barrier between advocate and resident. We had a difficult time communicating with each other in the beginning. Ms. Smith had a very thick accent

and had difficulty expressing her thoughts. She was not proficient in English, but was able to speak a little.

During her stay in a Safe Horizon Domestic Violence Shelter, Ms. Smith received counseling services, intensive case management and supportive services. She also participated in a 10-week parenting skills workshop, job readiness and independent living skills workshop. This advocate helped her navigate the social services system and served as a liaison to outside services.

Ms. Smith secured permanent housing and was very happy to

appear very happy. She seems more confident and secure. She was very thankful for all the services provided to her during her stay.
