- Senator Raptakis has kept his promise to the homeowners of Coventry and has spent the last three years consistently fighting the Town Council's sewer assessment scheme. The initial assessments were calculated to be \$20,000 to \$30,000 and even though the Town had received the funding to loan homeowners funds to pay for these horrendous assessments at approximately 2.75%, the Town Council wanted to slap a 6% interest rate on the loans! Thanks to Senator Raptakis' efforts, along with my work and that of my neighbors and other concerned Coventry residents, legislation was passed last year to reduce the interest rate to approximately 3%. This reduction will save EACH homeowner approximately \$7,500 of the life of a 20-year loan for these mandated sewer assessments.
