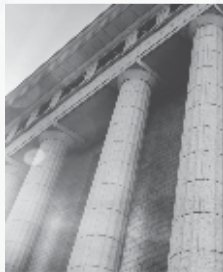

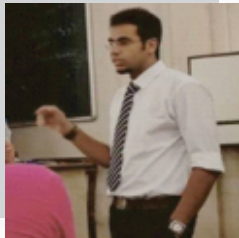

Lead Mentor- UG India

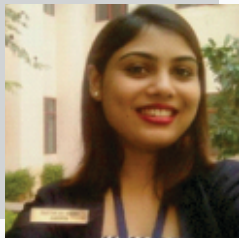
